A graduate of an accredited university is preferred, with a minimum of 10 years experience as an instructor or tennis administrator, and a competitive tennis playing background including USTA and college level play. Individual must possess strong organizational and communication skills and have the ability to develop and carry out the program goals and curriculums.

**Duties:** Under the supervision of the Tennis Manager, this position is responsible for the overall quality and development of FVPD adult tennis programs, instruction, and supervision. This position will include a strong focus on the recruitment, development and retention of travel team players.
